

# Freelance Brief - Fundraiser & Bid-Writer

#### Summary

Bedford Creative Arts is seeking to work with a freelance fundraiser to generate income from trusts, foundations and statutory grant-making bodies.

The role will work closely with the charity's Director to identify prospects, agree the case for support for projects or core contributions, and to write and submit applications on the charity's behalf.

This role has a focus on grant funding initially, however we are open to expanding the role to explore other avenues of fundraising such as individual-giving and corporate income in the longer-term (subject to the relevant experience of the preferred contractor).

Bedford Creative Arts is an arts charity working across Bedfordshire for 40 years, delivering projects that use art as a tool for social change. The company's turnover is £350-450k per annum with a regular revenue contribution from Arts Council England as part of their National Portfolio.

#### The Brief

We are seeking a freelance professional to support us in achieving our grant-focused fundraising targets for 2025-26 and beyond to include:

- Reviewing past applications, Business Plans and other internal information to articulate and update the Case for Support for company projects and for core income to achieve budget targets.
- Researching and identifying prospects for funding support, especially from trusts, foundations, Lottery funders and other statutory bodies.
- Creating a pipeline of targets to agree with the Director and Trustees, establishing a timeline for approaches and tracking and monitoring outcomes.
- Prepare budget proposals (working with the charity's producers and Director) for funding bids re-formatting budgets to fit funding requirements for bids and reporting.
- Writing and submitting grant applications to selected funders, agreed with the Director.
- Collaborate with the Director on the ongoing development of a sustainable Fundraising Strategy.
- Advising on other funding opportunities and approaches to other sources of funding (beyond grant funding).

The target for the year is anticipated to be c. £200,000.

The contractor is expected to:

- Take responsibility for their own administration and ITC to enable their successful fulfilment
  of the brief (access to BCA fileservers will be provided).
- Communicate regularly with the Director on progress, including attending strategy and planning meetings as required to aid research and provide updates on project development.
- Comply with the polices of Bedford Creative Arts including its Fundraising Policy, Equality, Equity & Diversity Policy and Information Governance policy.
- Communicate with other members of the BCA team, as required, to ensure they fully understand the organisation and its activities to enable successful delivery of the work.



The position is a remote working position to be delivered from the contractor's home, although occasional co-working space in Bedford can be provided.

The contractor is expected to attend occasional meetings of the staff team to be briefed on the work of the charity, some of which may be online or in our Bedford co-working space.

## **Skills and Experience**

We are looking for a fundraiser with skills and experience of:

- Trust and foundation, Lottery, and Statutory grant fundraising for projects with a turnover up to £200,000 or above.
- Securing both core funding (for charity revenue, staffing and overhead costs) as well as project revenue funding.
- Small-scale capital funding for projects (under £500,000).
- Excellent written and verbal communication skills.
- Self-motivated with the ability to organise and plan work and manage competing deadlines.
- Successful achievement of targets.
- Building effective relationships with funders.
- Securing funds for art projects or from arts specific funders e.g. Arts Council England.
- Displaying good attention to detail.

Desirable skills and experiences include:

- Creating fundraising strategies.
- Writing National Portfolio Organisation applications.
- Securing funds from individual-giving approaches and programmes.
- Corporate sponsorship and donations.

#### **Timeline**

This contract is to begin in April 2025 and is for a period of 12 months with a review period at 6 months to establish successful progress against objectives.

The contract may be extended for up to two years, subject to programme and budget demands.

We note that more time may need to be spent at the start of the financial year and expect quotations and profiling of work to reflect this.

### **Quotation for works**

The budget for this work is planned to be between £10-15,000 for 12 months, inclusive of any applicable VAT. Applicants are requested to provide a quotation for services that demonstrates value for money to the charity.

Travel expenses agreed in advance will be provided in addition at a rate of 0.45p per mile for private transport and upon provision of a receipt for public transport.



This is a freelance contract. The contractor will be liable for their own tax, insurance and pension contribution. This is not an employment contract.

## **Application Process**

Applicants wishing to apply should submit a CV (a description of their relevant work history and any relevant training, learning and skills) alongside a letter or email proposal (no more than 2 sides of A4) explaining:

- Why they would like the opportunity.
- Why they think they have the relevant experience and skills to deliver the brief.
- Their approach to delivering the brief including timelines, milestones and activities proposed.
- An itemised quotation for services clarifying:
  - The fee required for the work.
  - The daily rate incorporated in the fee.
  - How many days or hours will be covered within the fee.
  - Any VAT, if applicable.
  - Anticipated travel expenses.

We will obtain references from the successful applicant before appointment.
